## FACT SHEET - 2006

- ▶ **Founded:** On September 13, 1966, a non-profit community based corporation called MAP was chartered and later became the largest program providing comprehensive, high-quality Head Start in the State of Mississippi. Its first governing board meeting was conducted in October of that same year services to infants, toddlers and expectant mothers.
- ▶ **Philosophy:** MAP, in its diversity, represents a cross section of Mississippians working for and with disadvantaged children and their families. Our philosophy commits us to the belief that every child deserves a head start in life - an equal opportunity to develop character, talent, mind body and personality. We strive to prepare children to function in our society by providing life experiences; maximizing each child's potential for contributing, and ultimately determining the destiny of our country.
- ▶ **Mission:** Our mission compels us to not only serve the children, but to also serve as a catalyst for change and development for the disadvantaged community. We endeavor to be a mechanism for increased parental and citizen involvement in local and state communities.
- ▶ **Program Design & Management:** Our program is governed by a Board of Directors of 19 members, 6 of which are parent-elected and 1 Policy Council Liaison Representative; a Policy Council comprised of parents from each region (in all program options), a Board Liaison, and one community person (per region); and locally organized Parent Committees. The agency is also systematically organized to oversee and implement fiscal operations, human resource affairs, facilities, materials and equipment and research and development.

### Service Area

MAP is culturally, ethnically, and geographically diverse serving 21 of the 82 counties in the state: (Alcorn, Calhoun, Chickasaw, Claiborne, Franklin, Hancock, Hinds, Itawamba, Lauderdale, Leflore, Lincoln, Neshoba, Pearl River, Perry, Prentiss, Scott, Tippah, Tishomingo, Union, Warren, Winston, and Yalobusha).

- ▶ **Research & Development:** The foundational core of our program planning is the data collected and compiled by this arm of Program Design and Management. Its function encompasses (1) a comprehensive in-depth review and analysis of information about the local communities, children, their families, and available resources inclusive of competitors and potential partners, (2) Eligibility, Recruitment, Selection, Enrollment and Attendance (ERSEA), (3) client satisfaction analysis and (4) post Head Start tracking.
- ▶ **Program Services:** Our unique approach to providing comprehensive services include Child Health & Development, Education & Early Childhood Development, Disability Services, Dental, Nutrition, Mental Health, and Family & Community Partnerships (including services to expectant mothers).
